

MINUTES OF THE ANNUAL GENERAL MEETING



The International Football  
Association Board met in  
the Station Hotel City  
on Monday 15 June 1903  
at 11. am.

Present Captain P. M. Christie (Scotland) Presiding  
Messrs A. Stevenson (Scotland) G. Crump &  
R. P. Gregson (England) J. Davies &  
T. G. Thomas (Wales) D. W. Fay & J. Sheehan  
& J. Reid (attending) (Ireland). J. McDonald

Minutes The minutes of meeting held at Scarborough  
on 16 June 1902 were held as read &  
adopted

Resolutions of Board It was unanimously decided on this  
to be put at the motion of Mr Fay seconded by Mr Gregson  
under the Law that the resolutions of the International Board  
they apply to be added as a note at the end of each  
Law to which they may apply. It was  
subsequently left to Messrs Crump & McDonald  
to see this carried through

Proposals The following proposals by The Football Ass<sup>n</sup>

Proposed by	Law Affected.	Proposed Alterations.
THE FOOTBALL ASSOCIATION ...	Law 2 ...	Decision of International Board. Alter to read as follows:—"If this Law is not complied with, the kick-off must be taken over again."
THE FOOTBALL ASSOCIATION ...	Law 6 ...	Introduce after the word "opponent," in sixth line, "or with the play."
THE FOOTBALL ASSOCIATION ...	Law 9 ...	To read:—"A goal may be scored from a free kick which is awarded because of any infringement of Law 9, but not from any other free kick. When a free kick has been taken, the ball shall not be again played by the kicker or," etc.
THE FOOTBALL ASSOCIATION ...	Law 16 ...	Delete figure "2," in line one. Add at end:—"The Referee may refrain from putting the provisions of this Law into effect in cases where he is satisfied that by enforcing them he would be giving an advantage to the offending side."
